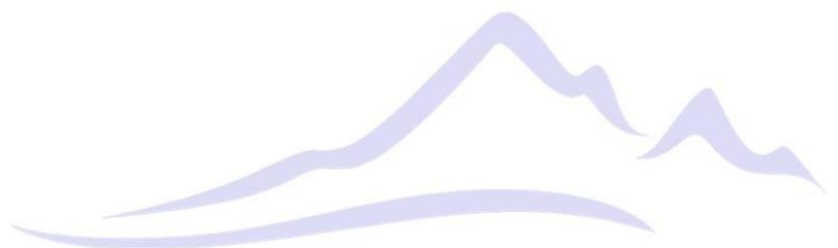

An 'Excess Animal Permit' is required to keep more than 2 dogs on an allotment with an area between 451m<sup>2</sup> and 4,000m<sup>2</sup>; and more than 1 dog on an allotment with an area less than 450m<sup>2</sup>. Once approval has been obtained, registration of this animal will then need to be on a separate application form.
